12:30 - 1:00 ET	<p><b>Time with Juvare CEO Bob Watson</b></p> <p>Kick off your afternoon with a Live update from our CEO on how Juvare is working to help organizations of all types prepare for critical incidents, collaborate with the Juvare Community, and respond to everything from tornadoes to COVID19, hurricanes, fires and more.</p>
1:00 - 2:00 ET	<p><b>Juvare Public Health Population Vaccination Support</b></p> <p>All clients are welcome, but Public Health Clients should attend this session which will be an overview of a new Juvare public health offering around Point of Dispensing (POD) Site Management and support personnel to establish and operate a non-traditional clinic site (POD) in which to offer COVID-19 vaccinations. The application will be designed to effectively manage free vaccination services to the general population.</p> <p>This Juvare offering may be used to complete all pre-vaccination planning such as determining POD location(s) and client flow, identification and assignment of key POD personnel, resource allocation, POD operation set-up, POD deactivation, and staff demobilization and population self registration and scheduling.</p>
2:00 - 3:00 ET	<p><b>Public Facing Website / Self-Registration (CORES 2020)</b></p> <p>All clients are welcome, but CORES clients should attend this session which will be an overview of Juvare's new public facing website, registration and scheduling capability. This new capability will directly communicate with a client's CORES application and can also be used to support the Public Health Population Vaccination and Testing Points of Distribution. Client's will now have the ability to make modifications to their questionnaires and landing pages.</p>
3:00 - 3:30 ET	<p><b>COVID-19 Data Collection and Reporting</b></p> <p>All clients are welcome, but facilities and public health clients that use EMResource should attend this session which will be an overview of how Juvare built a new inbound data collection tool so that our providers and public health clients can more easily collect data directly from providers. We will also explore how that EMResource data is then sent to CDC and HHS for monitoring on a national level.</p>
3:30 - 4:30 ET	<p><b>Inventory Management and Resource Requests in the time of COVID-19</b></p> <p>All healthcare clients should attend this session which will be an overview of a national level resource request and response process through EMSupply and Juvare Exchange. We will explore how on a local level you can collect resource requests and manage the response process up to the Strategic National Stockpile and down to an individual facility.</p>
4:30 - 5:00 ET	<p><b>Incident Command Systems and the Integrated Delivery Network (IDN)</b></p> <p>All healthcare providers should attend this session will be an overview of how Juvare is tying solutions together to provider corporate oversight and governance to incidents that are occurring at a facility level. We will focus how Juvare is utilizing Juvare Exchange to make sure all team members within an IDN can quickly be notified of the status of incidents that are occurring within a facility.</p>
